There have also been a number of recent significant developments and I mention particularly the continued expansion of the Branch network with a new premises opened in Githurai on the Thika Road, outside Nairobi under Manager **Gladys Ndung'u** and also the move to a larger and more prominent premises on Digo Road, Mombasa Island under Manager, **Adam Abdalla**. This now increases the total network to 65 branches which are making a significant contribution to the growth of D&S. We look forward to these new branch's success.

One of any organisation's most important stakeholders is its suppliers and D&S is particularly fortunate on the quality of our supplier base. One relationship that stands out, though, is that with **Grundfos**, the world leading Danish based pump manufacturer

that we have worked with for over 50 years, one of both company's longest relationships. We have grown together to both become industry leaders and our names are synonymous in our markets. As the market has developed the relationship has evolved, though in a recent strategy meeting that was held between top executives of both companies the strength of the relationship was endorsed and a mutual approach agreed building

on the already close association. Grundfos and D&S share many values, particularly a focus on Quality, and I look forward to future deepening of this already strong relationship.

Another achievement of note is D&S being listed on the London Stock Exchange's 2019 'Companies to Inspire Africa'. This is a well-researched analysis of progressive African companies and we are proud to have been selected.

Finally, I must mention expansion of the Company's **CSR** contribution managed by Executive **David Bolo** with some notable projects recently completed. Last year the number increased substantially with assistance given to over 65 beneficiaries, mainly through water supply installations for institutions supporting underprivileged children and about 40,000 people have benefitted. We are all proud of this contribution and we plan to increase the number of benefitting projects in the coming year.

D&S Water Treatment

D&S Water Treatment Division under Technical Director Philip Holi is an important Group activity and has recently delivered a number of customized solutions for industrial and commercial partners across the region. One project of note was a 30m³/hr water bottling purification plant which included a Dayliff DUF (ultrafiltration plant) pre-treatment for a Dayliff DRO (reverse osmosis plant). Entirely designed, engineered and manufactured at the D&S HO Technical fabrication facility in Nairobi, Dayliff plants are unique in the regional market as partners benefit from flexibility on design, reduced cost, shorter lead times

The end result is world class solutions offering optimized value and performance to D&S partners.
